You are sure to come away from this workshop with a better understanding of how a brand and a marketing strategy tailored to your NC's goals and objectives can help you "sell" your NC to your community and other communities across Los areas in which the Bureau has primary responsibility.

As Director, Mr. Robertson is responsible for managing a budget of \$150 million that involves preservation and maintenance of more than 7,300 miles of City streets, alleys and related throughways, 295 acres of landscaped traffic median islands and the City's 680,000 tree urban forest—the largest in the nation. He also oversees personnel in the construction of new street improvement projects, cleaning of unimproved lots, removal of brush from hillside properties, enforcement of street use and sidewalk vending ordinances including inspection during the movement of houses and other oversized loads on City streets. #### Jill Banks Barad – Valley Alliance of NCs

Jill Banks Barad is a recognized civic leader with achievements in a wide range of activities. Jill is Founder and Chair of the Valley Alliance of Neighborhood Councils. The Alliance, now in its fifth year, has been described as the "model of regional governance." Jill founded the Sherman Oaks Neighborhood Council and is in her third term as President. Jill served on the search committee to recommend to the Mayor the final candidates for DONE

presented five-day workshops and managed a tenperson training staff generating over \$2 million a year. She taught political science, theater and speech at Cerro Coso Community College and recruited and managed over 90 part-time faculty members. Flo served on a presidential advisory committee to review Social Science curriculum for the National Science Foundation. For the third time in 2008 she was named one of the 50 most influential nonprofit leaders in the country by The Non-Profit Times. Green was the first woman elected to a city council in Kern County where she developed a senior nutrition program and an Area Agency on Aging. Flo received a special commendation from the State of California and has been honored as a Management Innovator by the American Society of Public Administrators.

#### Donyale Hall – AmeriCorps Program Manager, Emergency Management Department

Donyale Hall is currently the AmeriCorps Program Manager for the Los Angeles Community Preparedness Corps. This AmeriCorps Program falls under the direction of the Emergency Management Department and has been instrumental in providing emergency preparedness awareness to community members throughout the City of Los Angeles. Previously Donyale worked as one of the original staff members of the Department of Neighborhood Empowerment spearheading the creation of Neighborhood Councils in Los Angeles. A native of Los Angeles, Donyale plans to continue her life-long efforts of empowering people to act.

She is currently a member of the American Institute of Certified Planners: and a member of the California Planners Roundtable.

She was appointed as Chairman of the Outreach Committee and Election Committee which nearly tripled election turnout. She revamped the TNC website, created and managed their monthly ezine, and works closely with the South Valley Alliance which works on District 3 neighborhood council outreach projects.

#### **Commissioner Paula Daniels – Public Works**

Paula A. Daniels is a commissioner with the Los Angeles Board of Public Works, which oversees the City's third largest department, comprised of over 5,000 employees and five bureaus. The Department of Public Works is responsible for the infrastructure of the City of Los Angeles; Commissioner Daniels provides leadership in the area of water quality, including watershed and urban runoff management, and water re-use.

Doug Epperhart helped organize the city's first operating neighborhood council—Coastal San Pedro. He has served on Coastal's board since February 2002, including four years as president. A regular contributor to CityWatch, Epperhart continues to concentrate on forging coalitions with other councils to influence government for the common good.
